Preamble

Catholic school divisions exist to provide a distinctive Catholic faith-based education. The faith and value dimensions of the Catholic faith are expected to permeate all aspects of instruction and school activities. Schools are expected to exhibit an atmosphere of prayer and be centres of gospel virtues.

Catholicism supports the belief that all parents are their child's primary educators. As such, the Regina Catholic School Division (RCSD) exists to provide a Catholic education for children of parents who are members of the Roman Catholic Church. However, in the inclusive and welcoming ethos of our Catholic Faith, non-Catholic parents who wish to have their students educated in a Catholic school may apply for admission. Parents not of the Catholic faith who desire a Catholic education for their children must be respectful of the teachings of the Catholic Church and agree to abide by the policies and procedures of Catholic school Divisions relating to religious instruction and the permeation of faith within all aspects of the student's school experience. However, Catholic school divisions reserve the right to deny admission to a non-Catholic student who will not abide by the policies of the Board relating to religious instruction, religious activities, and other such programs specific to our schools.

Application

Communication with parents who are registering children for the first time at an RCSD school is extremely important. It is crucial that an intake interview be set up with new families wanting to pursue a Catholic Education. The interview for admittance presents an opportunity for administrators to discuss the applicant's history of Catholic involvement and the motivations of the parents seeking a Catholic Education for their student. For the purpose of the admittance interview, students can be classified in two categories: Registration of Children of Catholic Parents and the Registration of Children of Non-Catholic Parents.

1. **Registration of Children of Catholic Parents/Guardians**

Completion of one of the following criteria would permit entry into a Regina Catholic School:

- Student's Catholic Baptismal certificate
- Parent's/guardian's Catholic Baptismal certificate

- A reference/recommendation from the family's/school's parish priest

2. **Registration of Children of Non-Catholic Parents**

The school division accepts only those who are sincerely interested in benefiting from the teachings of the Church and who want to experience the spiritual formation offered by the Catholic school. Admittance of non-Catholic students require the professional discretion of the Principal or designate. The following criterion can help guide a school-based administrator:

- a. In the spirit of *Truth and Reconciliation*, we recognize Indigenous families in their request for admission to a Regina Catholic School and their intent to receive Catholic faith formation in our faith-based environment.
- b. Non-Catholic students who may have been registered in another Catholic school division/school do not automatically qualify for admission and must fulfill the guidelines outlined in *Administrative Application 9100*.
- c. Students may be baptized in the Christian Tradition and be able to satisfy the Director, or designate, that the primary motive for gaining admission is the preference for the Catholic atmosphere and formation unique to the Catholic school and be willing to complete the necessary documentation indicating their acceptance of the Catholic formation and atmosphere of the school.
- d. Students may be a member of a recognized world religion which is not designated Christian or Indigenous spiritually¹.

If the principal is uncertain concerning admission of a student, the principal may refer the parents to the respective parish priest for a reference interview. After this interview, the parish priest makes a recommendation to the principal. However, it remains the responsibility of the principal to make the decision with respect to the admission of the student to the school.

3. **Acceptance of Children of Non-Catholic Parents**

If a principal or designate determines that a student of non-Catholic parents meets the required criteria the interview will proceed with a discussion about the Catholic faith. Topics for discussion can include daily prayer, Catholic Education classes, formal celebrations, masses, liturgies and the reception of the Catholic Sacraments.

The intake interview will conclude with the parents or guardians signing the Declaration of Status Form (see Appendix A).

Administrative Process

1. **Reporting Non-Catholic Student Applications**

¹ We recognize the diversity of Indigenous peoples and the distinct spiritual practices of Indigenous Peoples. We also acknowledge that the spiritual practice of the Métis people may follow their Indigenous or Non-Indigenous parents or a combination of both.

It is the responsibility of the principal to complete and return the "Reporting on Non-Catholic Student Applications" form to the designated superintendent on September 30th and February 28th of the school year.

2. Registration of students from Out-of-Province to Regina Catholic Elementary Schools

- a. Registration occurring during the school year:
The student will be placed in the same grade as attended in the previous school.
- b. Registration occurring at the beginning of the school year:
The student will be promoted to the grade after the one completed in the previous school.
- c. Placement may be changed by the Director or designate if the placement is found to be inappropriate.

3. Registration of students from Out-of-Division to Regina Catholic Elementary Schools

Catholic parents residing outside the City of Regina and desiring admission of their child(ren) into a RCSD school must complete the Out-of-Attendance Area School Request Application Form from one of the designated receiving schools. This request must be approved by the school principal and area superintendent.

4. Registration of students from Out-of-Attendance Area

Catholic parents residing within Regina and desiring admission of their child(ren) into a RCSD school outside of their attendance area must complete the Out-of-Attendance Area School Request Application Form. This request must be approved by the school principal and area superintendent.
